COOPERATION AGREEMENT

General

1. The Westsächsische Hochschule Zwickau and the Ural Institute of Economics, Management and Law have signed the cooperation agreement on the following:
 - Exchange of experience concerning the organization of educational process, teaching methods and education technologies
 - Academic exchange of specialists concerning the organization of educational process
 - Exchange of students, postgraduates and candidates
 - Organisation of joint scientific and educational programs, projects between both educational establishments in their mutual interest,
2. The academic cooperation between both institutions will strengthen the partnership and relations between Germany and the Russian Federation and increase the mutual understanding of working and living conditions.
3. Both educational establishments support the cooperation depending on their capabilities and resources. In order to be able to organize, implement and execute projects both universities agree to seek for additional funding provided by national and international organizations and funding agencies.

4. Each educational establishment shall sufficiently support professors, students and other members of staff who participate in exchange programs. This particularly refers to the organization of the stay abroad, the journey to the respective country, the conditions of stay and the organization of the academic program for exchange students.

Each participant is responsible for taking out their own individual health, accident and liability insurance. Prior to the stay abroad, each participant is furthermore responsible for gathering information about the terms and conditions of insurances, in particular health, accident and liability insurances.

In order to be able to provide all necessary documentation and confirmations, the host university will support guests in all visa-related matters. Please note that participants are individually responsible for applying and paying for a visa and possible fees.

Terms and conditions of the exchange programs for students, postgraduates and candidates are regulated by additional agreement.


5. The agreement is written and signed in English and Russian languages. Both variants have equal legal force.
6. All supplements and amendments of this cooperation agreement shall be done in written form.

Both parties reserve the right to cancel the agreement. In this case one party must inform the other about the cancellation of the agreement with at least six months' notice before the date of expiry in written form.

This agreement shall come in force and be effective for a period of five years from the date of signing.
